# SUMMARY ANNUAL REPORT FOR THE NRECA GROUP BENEFITS PROGRAM January 1, 2024 – December 31, 2024

This is a summary of the annual report of the NATIONAL RURAL ELECTRIC COOPERATIVE ASSOCIATION (NRECA) GROUP BENEFITS PROGRAM, sponsored by NRECA, EIN 53-0116145, Plan No. 501, for the period January 1, 2024, through December 31, 2024. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The NRECA Group Benefits Program (Plan) has committed itself to pay certain medical, prescription, dental, vision, disability, life and accidental death & dismemberment insurance and business travel accident insurance claims incurred under the terms of the Plan.

#### **Insurance Information**

The Plan has contracts with Metropolitan Life Insurance Company, Vision Service Plan and Starr Indemnity and Liability Company to pay certain vision, life, accidental death & dismemberment and business travel accident claims incurred under the terms of the Plan. The total premiums paid for the Plan year ending December 31, 2024, were \$51,328,809.

Because some of these contracts are so-called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the Plan year ending December 31, 2024, the premiums paid under such "experience-rated" contracts were \$5,922,745, and the total of all benefit claims paid under these experience-rated contracts during the Plan year was \$4,815,377.

### **Basic Financial Statement**

The value of Plan assets, after subtracting liabilities of the plan, was \$694,636,251 as of December 31, 2024, compared to \$610,863,761 as of January 1, 2024. During the Plan year the Plan experienced an increase in its net assets of \$83,772,490. This increase includes unrealized appreciation and depreciation in the value of Plan assets; that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the Plan year, the Plan had total income of \$927,908,828, including employer contributions of \$848,189,531, realized losses of (\$35,443,485) from the sale of assets, earnings from investments of \$113,095,374, and other income of \$2,067,408.

Plan expenses were \$844,136,338. These expenses included \$38,781,771 in administrative expenses, and \$805,354,567in benefits paid to participants and beneficiaries.

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
